IMPLEMENTATION EXAMPLES

Plan for Community Participation

- Throughout the planning process, the <u>City of Austin</u> had nearly 200 Austin residents participate. A
 steering committee provided direction and accountability and five advisory groups helped craft
 goals and strategies informed by input from a Community Climate Ambassadors Program.
- The City of Tallahassee developed the <u>Community Resilience Plan</u> with extensive stakeholder engagement and community outreach. This consisted of targeted meetings and workshops through community events, neighborhood meetings, and nonprofit roundtables.

Understand background and historical context of the community

- Not only does the <u>Austin Climate Equity Plan</u> explore the historical context of shocks and stressors, but an entire section of the report is devoted to understanding policies and structures that perpetuate racial and economic inequities.
- The <u>San Diego draft Climate Action Plan</u> (still in draft at the time of this writing) aligns the City's Climate Equity Index map with historic redlining maps to visualize similarities and recognize the legacy of disinvestment in particular neighborhoods.
- The <u>Pittsburgh Resilience Strategy</u> recognizes the legacy of segregated and inequitable schools, neighborhoods, and labor markets through their exploration of historical factors, such as redlining, and a detailed summary of how these factors present themselves in the City today.
